- Article 1. In response to global trends in digital teaching and reforms in higher education digital learning policies, Chung Yuan Christian University (hereinafter referred to as "the University") has established the Digital Course Reward and Subsidy Implementation Project. The purpose of this project is to encourage faculty to engage in the development and offering of Massive Open Online Courses (MOOCs), distance learning courses, and the use of international open educational resources, with the aim of enhancing teaching quality and improving student learning outcomes.
- Article 2. For the purposes of this project, digital courses refer to those designed by instructors based on the course syllabus, where each course contains multiple teaching topics. Each topic should include teaching video segments ranging from 5 to 15 minutes, with the total course video content ranging from 6 to 18 hours. These courses should also include online interactive discussions, quizzes, and other learning activities.
- Article 3. This project is intended for teachers offering MOOCs, distance learning courses, or other digital courses in collaboration with the Ministry of Education's digital initiatives or in alignment with the University's Digital Education Development Office policies. These courses must be hosted on external platforms recognized by the University.
- Article 4. Teachers may choose one of the following methods for applying MOOC materials in their courses:
 - (1) Distance Education Credit Courses: At least 50% of the course hours should be conducted online, with the remaining hours taught in person.

These courses must comply with the Ministry of Education's "Regulations for Distance Education" and the University's "Regulations for Distance Education" and "Distance Education Course Evaluation Project."

- (2) Flipped Classroom Teaching: This method combines MOOC video materials with a flipped classroom model, offered during the regular semester or summer term. In addition to online video lectures, the course should include in-person assessments, explanations, discussions, and assignments. In-person teaching hours must be specified in the course syllabus before the start of the course.
- (3) Online Platform Teaching: Fully online courses offered on University-approved platforms, aimed at a broad audience including general public, inter-university students, freshmen, and high school students. These are large-scale open online courses (MOOCs).
- Article 5. For MOOCs developed under the Ministry of Education's digital initiatives, a compensation of 7 times the recording hours will be provided for each hour of completed video content. Compensation is based on the Ministry of Education's "Hourly Compensation Standards for Lecturers." If a course is co-taught by multiple instructors, the distribution of recording hours must be specified at the time of application. This compensation is granted only once per course. (For non-Ministry of Education funded courses, teachers may apply for teaching resource production subsidies from the University.)
- Article 6. Subsidies and rewards may be granted for MOOCs or distance learning courses in alignment with the Ministry of Education's initiatives or the University's policies under the following conditions. (Courses offered as self-learning or funded by external platforms are not eligible for these subsidies.)
 - (1) Policy Feature Courses: If a course is selected as a policy feature course, it will be incorporated into the University's distance education offerings. Upon the teacher's application and the University's approval, such courses are not subject to the usual hourly limit.
 - (2) Teaching Assistant Subsidy: A monthly subsidy for teaching assistants will be provided, based on the number of enrolled students, for up to 40 hours per month during the course period. The Digital Education Development Office may adjust this subsidy based on the specific needs of the course.
 - (3) Teaching Material Development Subsidy: Teachers may receive a

subsidy for student work hours during the material development and recording phase. This includes assisting with studio recording, data collection, and the preparation of teaching materials. (This subsidy does not apply if the teacher has already received a teaching resource production subsidy.)

(4) Course Management Subsidy: For courses offered on Universityapproved platforms, a subsidy will be provided for the teacher's online course management activities, such as assignments, quizzes, and student-teacher interactions.
