Article 1. In response to the global trend of digital learning and developments in higher education, the "Subsidy Project for Students Enrolling in Digital Courses on External Platforms" has been formulated. This project aims to encourage students to utilize digital educational resources effectively, enhance their international language skills, broaden their perspectives, and foster autonomous digital learning capabilities.

Article 2. Award Procedures:

- (1) Eligibility Requirements: All current students at the University who enroll in and complete "MOOCs Micro-Credit" courses, which are recognized by the respective departmental curriculum committees and listed in the university's course selection system, are eligible to apply. Eligibility is contingent upon registering on the relevant platform during the semester, paying for the course, and obtaining a "Verified Certificate" or an equivalent passing certificate.
- (2) Application Process: Students must submit their applications before the end of the semester in which the course is recognized, adhering to the designated application period as announced. The application should include original copies of the course completion certificate obtained during the semester, screenshots of the grade report, and proof of payment for course purchase. Subsidies will be granted following review and approval.
- (3) Subsidy Guidelines: Each student is eligible to apply for a subsidy for one course per semester, limited to one certificate per course. For courses with monthly subscriptions, the subsidy is capped at two months. Courses with annual subscriptions are not eligible for this subsidy. The number of available subsidies and their amounts may be adjusted based on the annual budget.

(4) Subsidy Standards: The maximum subsidy is based on the course payment or certificate fee set by the platform for each specific course session. For courses taught in English, the subsidy can reach up to NT\$3,000 per course, and for those taught in Chinese, up to NT\$2,400 per course. If a discount is applied to the course fee, the subsidy amount will correspond to the rounded total actually paid. Subsidy standards are outlined as follows:
